## Report from Fire Chief, George Lenz

#### a. Fire Hall Renewal Select Committee:

Bob Leggett, chair of the committee introduced the committee members and provided a progress report for the Fire Hall Renewal project. The committee has a plan of what they are hoping to build. Plans need to be finalized so that costs can be firmed up.

A public meeting was held in October and another one will be scheduled as the project progresses. Financing will also have to be address. Monies will need to be borrowed, either from the province or privately. Ratepayer approval must be obtained in order for the DBID to borrow

#### b. Questions from the floor:

G. Dussault: The operator's report mentions that Well #1 is too close to the building septic, will this well be decommissioned?

A.: Well #1 is currently off line. It is anticipated that the septic field will be moved as part of the new hall project and Well #1 can be brought back on line at that time.

G. Dussalt: Do we have 7 or 8 production wells?

A.: We have 8 wells but only 7 productions wells (Well #7 has no pump).
