2017 Budget Information - October 19, 2016

DBID Committees have been meeting over the last several weeks to review the 2017 operating and capital budgets line by line. The DBID trustees will be considering the 2017 budgets and required revenue for 2017, including the 2017 tax rates for Waterworks and Fire Protection, at the regular October board meeting.

Rate payers are welcome to attend and there will be an opportunity to ask questions regarding the budgets at the regular board meeting.

Once the budgets have been finalized and approved, copies will be available on the website and from the office.

Draft budget packages will be available from the office and on the website October 14, 2016

Fire Department News

**October 15 – April 15
Category 2 open burning is allowed without a permit.
Conditions apply.**

Confirm...before you burn! Check Environment Canada's daily ventilation index for Central Vancouver Island to confirm if burning is permitted. Outdoor burning is restricted when the index is POOR or FAIR. The conditions must be GOOD on the day you burn as per Bylaw No. 223.

Of note, a clear sunny day isn't a reliable indicator that you can burn - you must check the ventilation index. Be considerate of your neighbours when burning so you don't impact their daily routine or health. Burn materials hot, infrequently and **ONLY** when venting permits so the smoke goes straight up.

How do you compare?

Some comparison numbers for this invoice period:

- 2% of all households used no water
- 40% of all households used less than 40 m³
- 30% of all households used between 40 and 74 m³
- 10% of all households used between 75 and 100 m³
- 18% of all households used over 100 m³

Fire Hall Replacement

The **Fire Hall Renewal Committee** has been busy in 2016 working on developing drawings for the new fire hall. After several updates, the committee is close to having a set of drawings that can be used going forward to start estimating construction costs.

The Committee has solicited input from the Deep Bay Volunteer Fire Department members and committee members have visited several newer fire halls in the region to assist in determining best practices for layout and functionality.

It is the intention to have drawings finalized in early 2017 so that a presentation can be made at the 2017 DBID AGM.

- 2017 Parcel & Fire Protection Tax** invoices will be issued in January in addition to the Quarterly Water Tolls invoices. Please be sure to arrange payment if you will be away (taxes are due Feb. 28, 2017).
