Other business

- a. **Fire Hall Renewal Select Committee:** Verbal report provided by Bob Leggett. The committee is made up of 2 trustees, 2 fire department members and 4 members of the public. Committee has met a couple of times and looked at current site as well as touring the Meadowood Hall (Dashwood No. 2 hall). Committee will be reporting to the board and is committed to getting the best bang for the buck.
- b. **Deep Bay Fire Rescue Society:** AGM for the society is April 29th. Memberships can be renewed at this meeting or at the DBID offices. The society is looking for new members to serve on the board. Thanks to the DBID for providing space in the Pipeline newsletter to promote the society's activities. Next bottle drive is coming up May 23rd and the society is hoping to have more events this year to raise funds towards a new fire hall.
- c. **Questions from the floor:**
 - G. Dussault: Wages and benefits increased by 5%, this is higher than CUPE employees are getting
 - A: Office staff has been provided with a percentage of gross wages in lieu of benefits as the district is too small to provide a benefits package.
 - G. Dussault: Why are vehicle expenses up?
 - A: The 2014 budget was higher to allow for repairs and maintenance but the actual 2014 expenses came in below budget and below 2013 expense levels.
